

## SHIRE OF SHARK BAY PUBLIC NOTICE

## Development Application – Proposed Alterations/Additions to Existing House and Ancillary Dwelling, and Proposed Outbuilding - Lot 3 (143) Knight Terrace, Denham

The owners of the abovementioned lot have lodged a planning application proposing to construct an outbuilding to the rear of the lot. They also proposed alterations and additions to the existing single house and ancillary dwelling on the property.

Under the Residential Design Codes the permitted aggregate size of an outbuilding on a lot is  $60m^2$  in floor area, with a 2.4 metre wall height and 4.2 metre ridge height.

The application entails variations to the R Codes for the outbuilding as the proposed floor area is 80m², the wall height is 3.6 metres and the roof height is 4.26 metres.

A side setback variation to the west lot boundary is also proposed. An extension to the house is proposed to be setback 1.2 metres in lieu of 1.5 metres.

Prior to determining this application, the Shire would like to provide an opportunity for public comment on the proposal. The development plans can be viewed below or at the Shire of Shark Bay 65 Knight Terrace, Denham during office hours.

Should you wish to make a submission on the proposal, your comments (in writing) will need to be lodged with Council within 14 days by **2 April 2024.** 

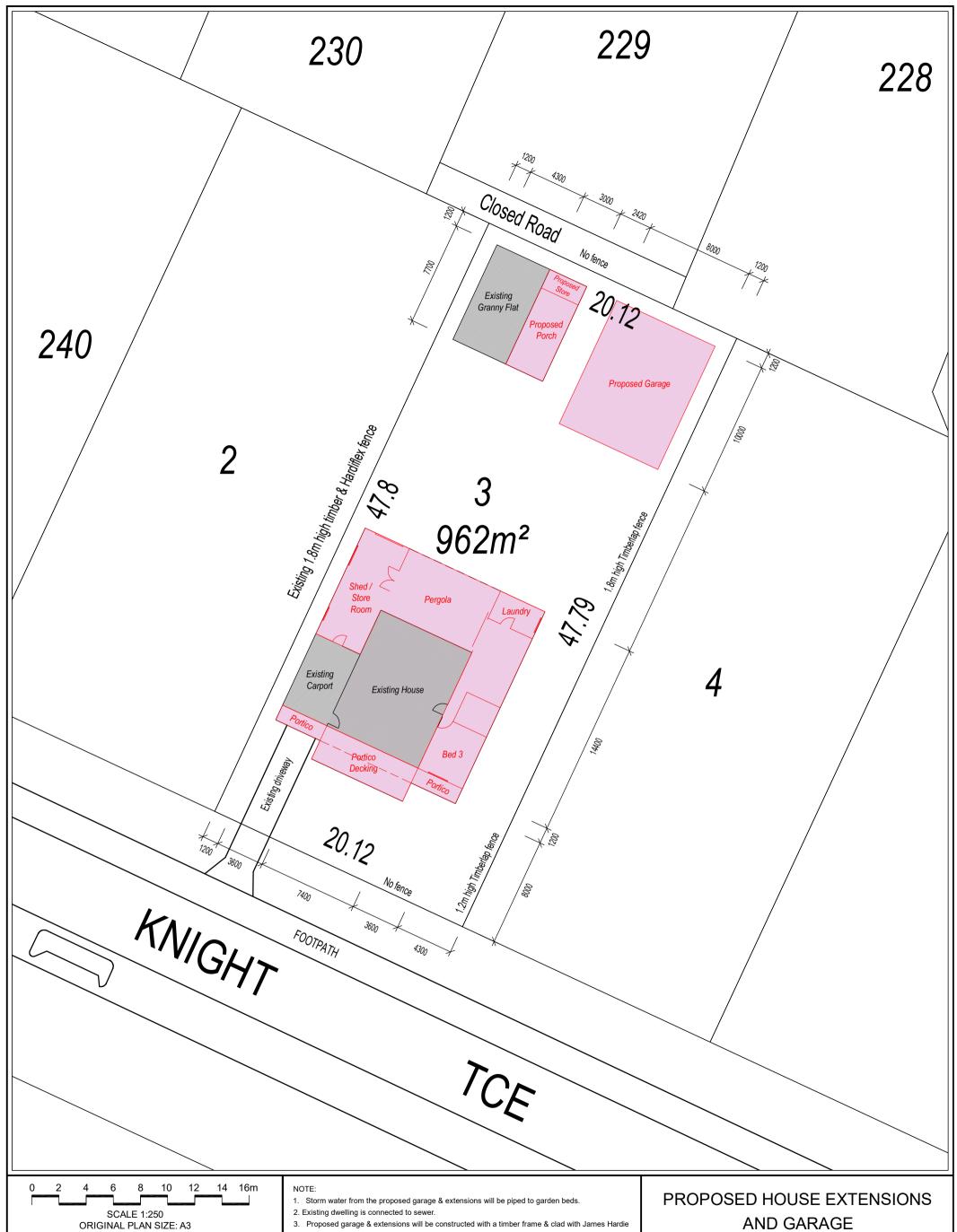
Please note, if no comments are received by the closure date, we will assume that you have no comment you wish to make, and the application will be assessed and determined on its merits and without any further consultation.

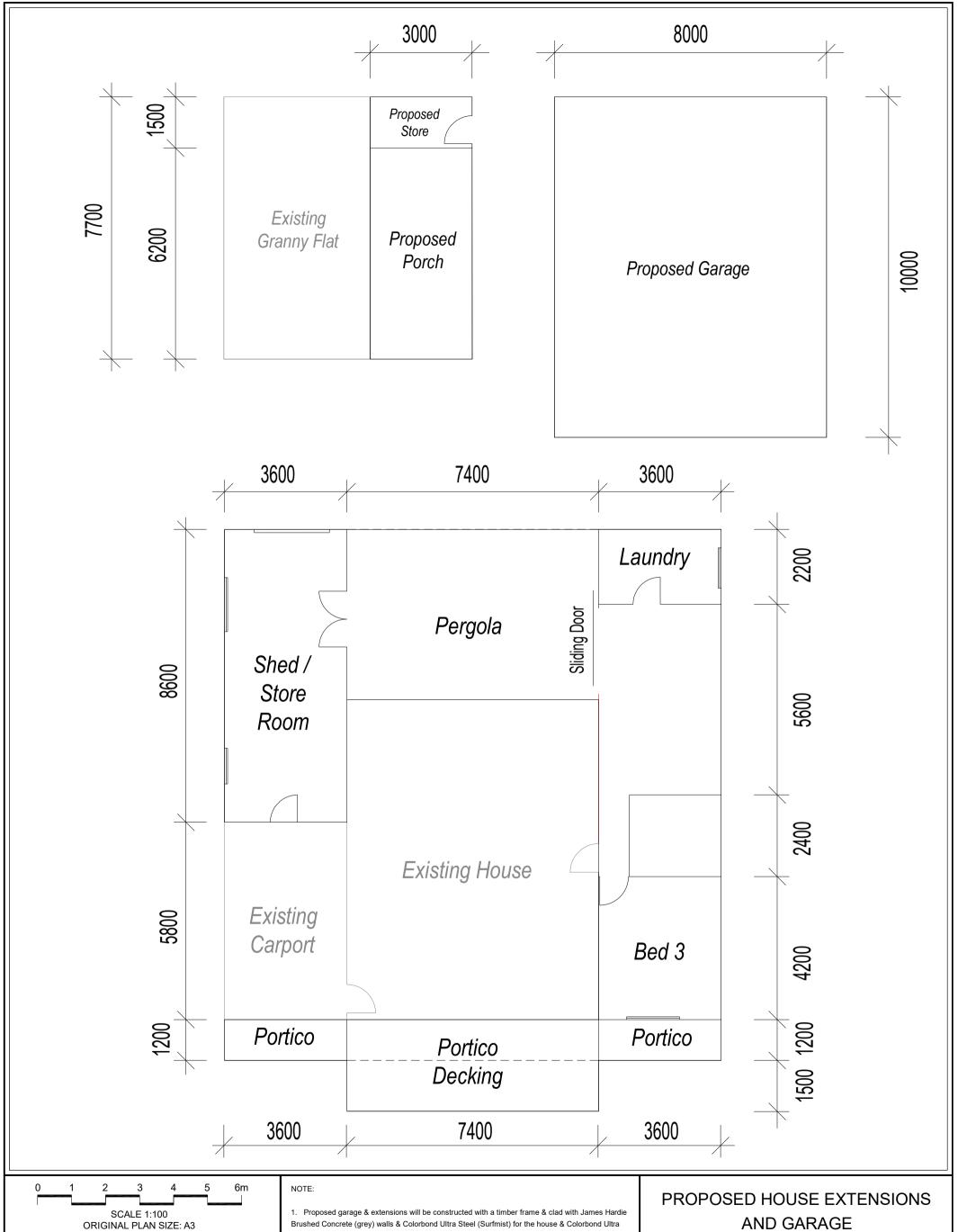

143 KNIGHT TERRACE **DENHAM** Shire of Shark Bay





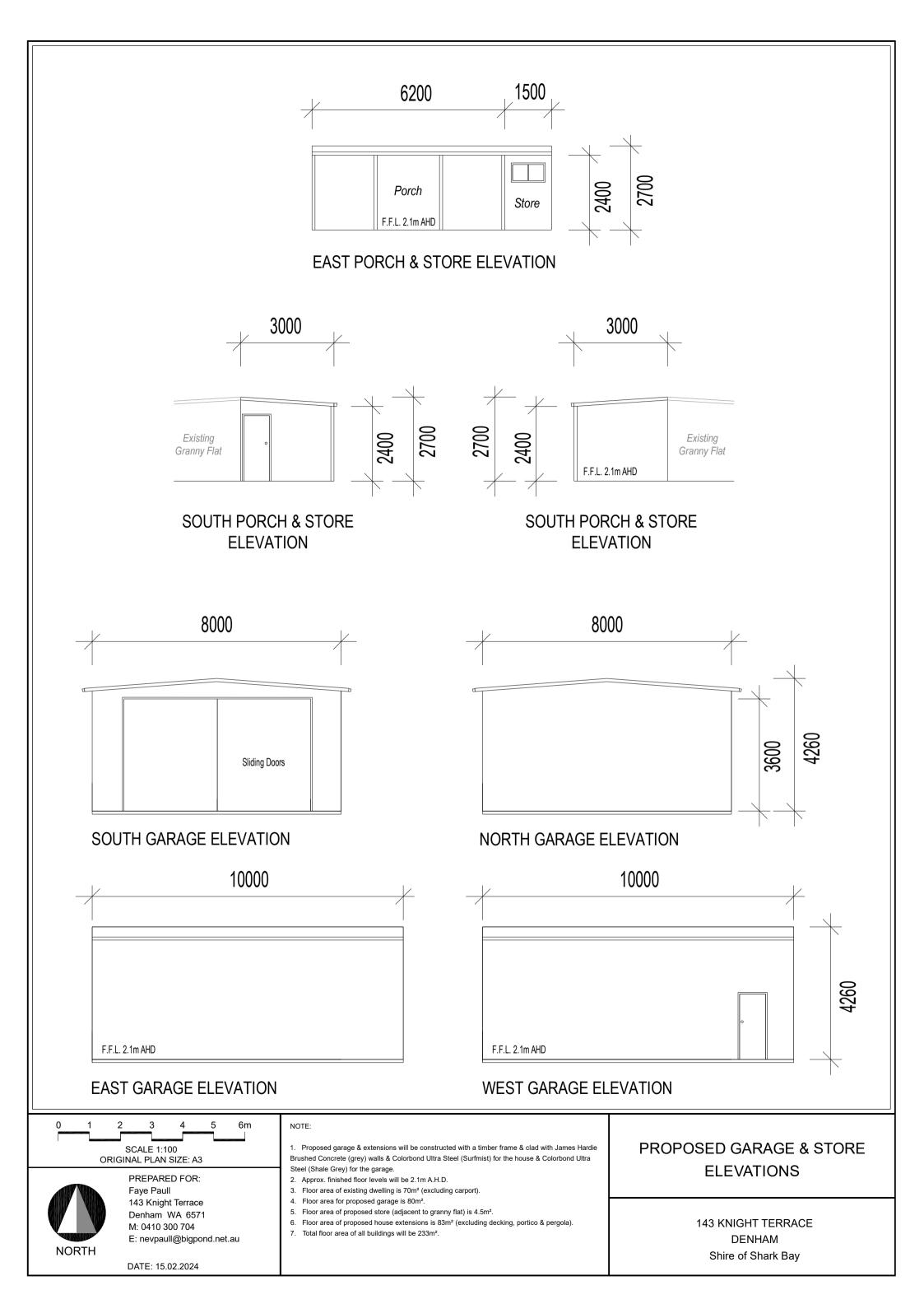

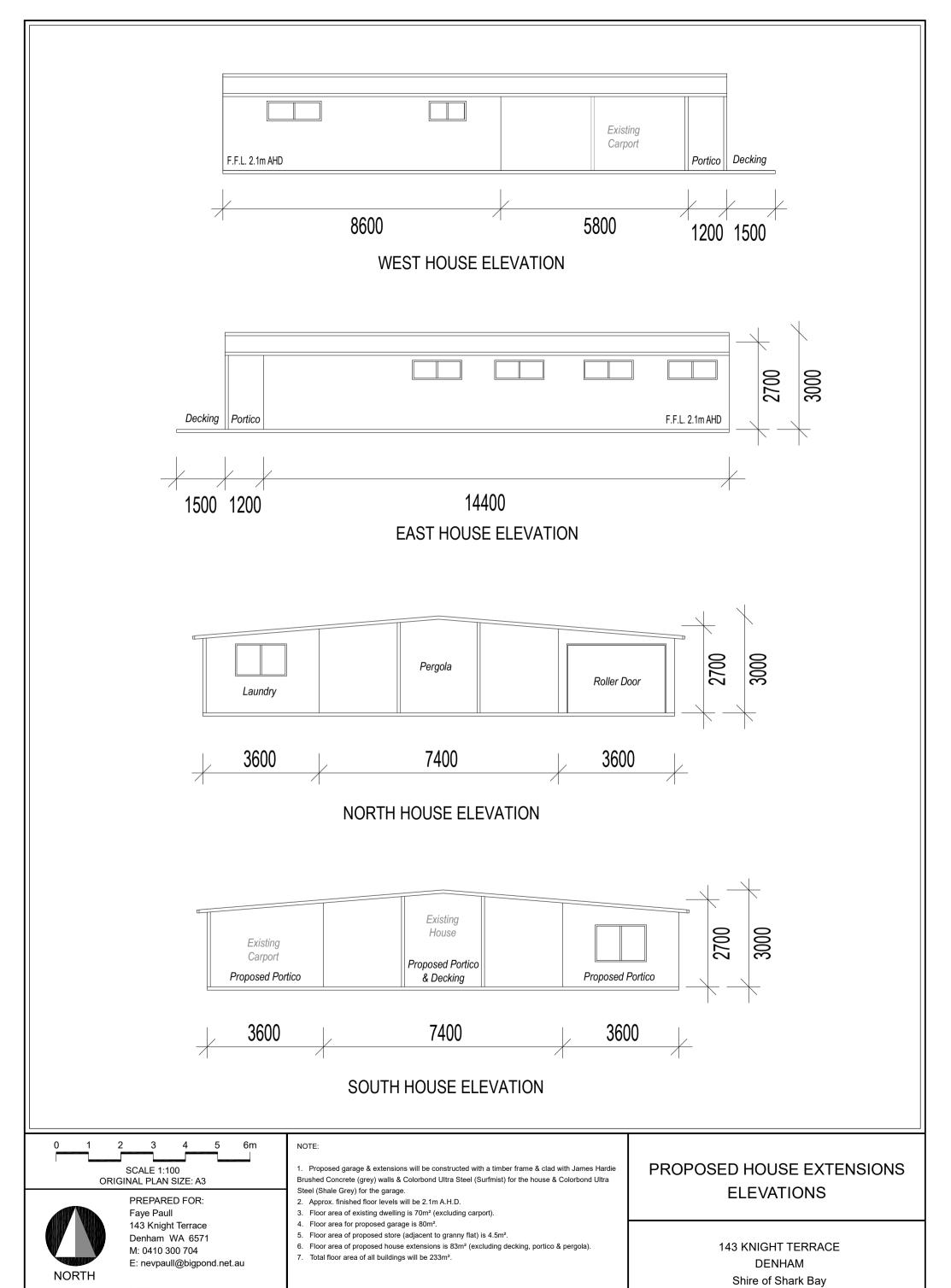
