**DESIGN & DEVELOPMENT;** The staff of West Coast Fireworks will be responsible for the preparation of all fireworks at our main magazine and workshop facility. Each item will be inspected, labelled, waterproofed, and made ready for use regardless of the weather conditions.

Our storage facility is the largest in Western Australia, and we have an extensive range of pyrotechnics, including state-of-the-art effects that Display can draw from. Additionally, we will ensure sufficient contingency products are prepared at no additional cost, which will enable us to handle minor disruptions or changes without any issues.

**APPROVALS & REVISION;** Once the design is approved, West Coast Fireworks will seek approvals from the WA Police, local council, DFES, and CASA. Then, they will submit the fireworks permit to DMIRS, which will allow them to review any necessary safety procedures related to site issues.

**IMPLEMENTATION;** West Coast Fireworks will transport all fireworks and equipment to the site, implement safety measures, and set up the display.

Single shot effects. These effects have a height from 20m to 70m depending on requirements, generally used at the beginning of a display, where firing area is limited or close proximity to spectators



Roman Candles are a multi shot rapid fire from a single tube, these can create some exciting and unique effects.



Multi shot cakes, fan shaped, W, X, Z and V cakes create a duplicate pattern of each shot, either in the same colour to give a fuller effect or change colours as the cake progresses, the multilevel cakes are designed to create an impact at midlevel, the visual effects are stunning and create unique firing patterns that are set to “wow” audiences with their elegant patterns and high energy colours.



## Safety Records and Measures

Safety is the core of West Coast Fireworks, employees and spectators are at the forefront of any discussions made regarding design and implementation of our displays.

In nearly 40 years, spanning two generations we hold a 100% safety record, both for displays and work safe practices. We have worked extensively over the years with Dept. Fire and Emergency Services as all of our staff have a background or are currently involved with one of the 3 emergency services. We have also liaised closely with the Dept of Mines, Industry Regulation and Safety regarding current code of practices and safety regulations.

## Fire Services

- All displays will be guided and in consultation with the local Fire Authority.
- West Coast Fireworks monitors all Fire Weather Warnings issued by the Bureau of Meteorology in the area of Fireworks display.
- West Coast Fireworks has its own light tankers, Each fire-fighting vehicle has a water carrying capacity of at least 500 litres is fitted with at least 20 metres of 19mm diameter fire hose; has a pump capable of delivering 120 litres of water per minute at 700 kpa through an adjustable nozzle having a full spray pattern capable of projecting a six metre jet of water; and is capable of traversing the area where the display (and fallout areas) is held.
- Each fire-fighting vehicle is crewed by at least two (2) personal trained in Introduction to Bushfire Fire-fighting or equivalent.
- West Coast Fireworks Chief Pyrotechnician will ensure that all fire safety precautions are taken into account in the firing zone.



## Fire Services 2022

West Coast Fireworks has, as part of its ongoing safety program, supplied a 500 litre light tanker for the past 10 years at no charge to our clients, along with water pumps and, above the current regulations, 20 litre fire extinguishers.

All of West Coast Fireworks staff have basic bushfire fighting skills and most have been or currently are Volunteer fire fighters, Fire captains, SES personal and ambulance officers.

As the new Department of Fire and Emergency Services (Dfes) regulations come into effect, and light tankers are now a mandatory requirement of firework displays under certain fire ratings and Dfes direction, we will still provide this service at no additional charge.





## Pyrotechnic Product Safety

- West Coast Fireworks is one of the largest importers of fireworks in Western Australia. We guarantee the quality and supply of pyrotechnics for a display. Our products are imported directly from our factories in Luiyang, China where the best Japanese chemists and up-to-date technologies are used to create stunning colours and combat environmental issues within the industry, without compromising on safety standards. Our Chief Pyrotechnician, Ken Boyland designs each effect, and our products are thoroughly tested throughout the manufacturing process and inspected before leaving Luiyang.
- 
- Once our products arrive in Australia, we test a sample of each cake and shell for quality, take photographs, and report our findings to ensure we deliver only the best products to our clients. Our aerial shells are constructed using recycled cardboard and are designed to break apart into small pieces once they're fired. They are also designed not to burn during the flight process, which reduces the risk of causing fires. All West Coast Fireworks products meet or exceed Australian and International Standards.
- All West Coast Fireworks products are tested, photographed, and documented before being sent to public displays.
- All our fireworks are constructed to meet or exceed ISO and Australian Standards for safety and reliability.
- All West Coast Fireworks Pyrotechnicians are professional operators and hold the highest qualifications. Our pyrotechnicians and crews have regular training sessions to ensure best practice at our displays. Our trainees are not licensed until we are happy that they have shown the dedication to safety we require.



All of our aerial shells are manufactured to the highest standards, exceeding Australian Regulations. They are tested at every step of the manufacturing process, we use recycled treated cardboard to minimise hot debris and a double timing fuse for added safety.

## On Site Safety / Methodology

### Transport

West Coast Fireworks are the only firework company in WA to hold a CAT 3 transport of explosives licence, which means we do not rely on other companies to transport our products and resulting in our products being there on site on time.

West Coast Fireworks Australia owns several fully-licensed explosives transport trucks and trailers. These vehicles and trailers are fully compliant with the requirements of Class 3 (i.e. highest level) transport. We will use one of these vehicles or trailers to transport the fireworks to Hopetoun. The transport will occur evening before the display, with delivery to site as early as possible.



## Bump In Day

West Coast Fireworks will confer with on-site event officials as to specifics on setting up area.

The day prior to bump-in the crew chief and other technicians will conduct a site walkthrough to make a final site risk assessment and confirm that the safety plan is relevant and adequate. This is to ensure there are no surprises on bump-in day.

## Firework Installation

West Coast Fireworks will ensure the fireworks exclusion zone, signage and security will be in place around the area, before the fireworks team commences work.

The day prior the crew chief and other technicians will conduct a site walkthrough to make a final site risk assessment and confirm that the safety plan is relevant and adequate. This is to ensure there are no surprise on set up day.

Before work commences on the display, a toolbox briefing will occur amongst the site team. As early as possible on the morning of the display, the West Coast Fireworks vehicles will deliver both hardware and fireworks. After these have been unloaded, the crew will begin the task of building aerial display and setting out ground cakes to maximum viewing effect.

To ensure safety, we will place fire extinguishers at all firing points beforehand. We will make water and sunscreen available to crew. All workers will be required to comply with sun safety and relevant WHS requirements. Before any work to set fireworks commences, the crew chief will ensure that all Risk Management Plan requirements are in place – for example, that the work area has been signed as a No Smoking / No Fire zone. West Coast Fireworks will set and install the fireworks in accordance with the Design and Risk Management Plan.

The basic parameters for this Event will be:

- Set out Areas required for aerial firing this will determine firework patterns.
- As items are set up, they will be covered and electrically shunted for safety
- Midlevel and ground ordinance will be set out, surveying best vantage points and visual effect within the area

The crew chief will test all electrical circuits in the early afternoon , to allow for enough time to rectify any faults. Once the ordinance is in position, wired and secured and all testing has been completed and rectified, if necessary, we recommend that the time code signal or start signal system (whichever is preferred by Authority) is tested at this time.

## Discharge Fireworks

The crew will have completed full electrical inspections and testing by 4pm the day of the display West Coast Fireworks recommends a final time code and communications check is also completed at this time. These timings allow for sufficient leeway prior to the Exclusion

Zone site check at 5pm.

The display will commence once final approval is obtained from CASA.

West Coast Fireworks has experience at this location in terms of working with CASA. We will maintain a direct line to CASA to avoid miscommunications, noting the final approval to shoot comes from them. We have found with good planning and communication that this has not been a problem, and delays, if any, are minor.



Discharge of the fireworks will be controlled by the crew chief. All firing positions will be selectable and controllable by the crew chief, meaning that a single position can be isolated and disarmed if necessary (e.g. due to breach of the exclusion zone).

## Clean Up

The crew will commence site clean-up immediately after the Display. Crew will start to pull down all aerial mortars for easy storage and transport.

Removing fireworks and hardware is our top priority. Once all live materials and hardware have been safely packed away, we will begin the clean-up process. Our crew will collect and dispose of all packaging and debris in a safe manner. After the pontoon has been removed and everything is packed away, we will do a final sweep of the shore to collect and dispose of any remaining debris.

Please note that firework debris is mostly paper, and it can land far and wide. This debris is biodegradable and breaks down quickly. The crew will conduct a vigorous clean up post show, however some small paper debris may remain – this is usually very minor and will break down safely soon afterwards.

## Bump Out Day

After the fireworks display, West Coast Fireworks will begin the process of removing all the necessary equipment. This includes loading the firing boxes and any misfired fireworks material onto authorized vehicles to depart from the site as soon as possible. All other vehicles and equipment will leave the site the following day, and there will be a secondary clean-up in daylight hours.

## Addition Risk Management Notes

### Site Access

- Site Security is important to ensure a safe display.
- Access to the fireworks set up area is restricted and takes effect from the moment the fireworks are delivered to the firing site. This ensures the safety of the public and provides the fireworks production crew with a safe working environment.
- An exclusion zone will be established around all fireworks installations and firing sites. The exclusion zone will be:
  - Equal to, or greater than the recommended safe distance for the largest calibre item included in the display (This will take into account weather conditions at the site on the day); and
  - A restricted access area from the moment the fireworks are on site.
- The fire-site area will contain live pyrotechnics and access to the site area is totally restricted to pyrotechnicians and their authorised workers.
- The client shall provide bunting, barricades, patrolled or enforced security zones and such security as is necessary to ensure the safety of the exclusion zone.
- No unauthorised person shall be permitted access to the site in any circumstances.
- Security staff will be restricted to the perimeter of the site. Emergency Services personnel are only permitted entry if requested or accompanied by the senior pyrotechnician.
- No person under the age of 18 shall have access to the site except under full and attentive adult supervision.
- No person under the influence of drugs or alcohol shall be permitted access to the site;
- The exclusion zone is to be maintained around the site until at least twenty minutes after the display to ensure no unexploded product remains. After twenty minutes, lesser access restrictions shall apply until the area has been cleared of mortars, firing equipment, and spent items.



## Firing Site

- The firing site shall be clear of debris and possible fuels, including chemicals, paper and dry grass, prior to the setting up of the site.
- Fire extinguishers will be provided at all sites (extinguishers will be maintained and located according to Australian Standards).
- There will be adequate signs placed around the site to advise the public not to enter.
- Appropriate clearances are to be maintained between fireworks and telecommunication equipment of all types. Mobile phones are not to be used on site within five metres of the fireworks.
- No cigarettes or naked flames shall be used within 30 metres of any fireworks:
- Specific risk assessments will be carried out at each display site to address any non-generic hazards. Such hazards might involve proximity to livestock, nearby bush in the summertime, buildings, wetlands, and ecologically sensitive or indigenous sites.

We have reduced our use and reliability on plastics and invested our future in biodegradable cardboard and mould pulp cakes.

**We currently use many ways to help reduce our carbon footprint:**

**Strict Recycling:** We use recyclable products when this choice is available

**Waste Reduction:** We prefer to use reusable products within our business and reduce our non-recyclable waste

**Fleet Vehicles:** West Coast Fireworks uses low fuel consumption vehicles and the reduction of CO2 emissions through car-pooling.

**Energy-Efficient:** We have a policy that reduces electronic consumption in our business, the use of natural light and solar sustainability in our workshop and offices.

**Buy and Support Local:** Each of our pyrotechnicians is based in WA, from Port Hedland to Broomehill, with a few in the greater Perth Metropolitan area. Each pyrotechnician has a locally sourced team that can include up to six team members. West Coast Fireworks is a family-owned and operated business that supports local employees and businesses. When it is at all possible, we always use materials and equipment that are sourced locally. The local knowledge of the areas where we work has been a great source of information over the years and, in some instances, has led to community involvement as ground levels.

West Coast Fireworks is a business that cares about the environment, which helps us reduce our impact on the environment.

## Committed to sustainability

Our manufacturing and logistics headquarters, located on a beautiful 250 hectare property in rural Western Australia just north of Perth, is part natural habitat with native flora and fauna such as blue gum trees, cockatoos, kangaroos and other native wildlife. We also run a sustainable cattle and sheep pastures, We encourage the planting of trees on this land; the property currently has more than 1,000 native trees, more than 400 of them mature eucalypts. This fauna offsets close to 200 tonnes of carbon emissions every year.

We have recently in conjunction with Northern Agricultural Catchments Council Inc taken more steps to sustainable farming and planted Growing Great Ground perennials, which will not only encourage local fauna to the pastures, it will also generate a better source of grazing to the animals that reside here. Ground perennials also have the added advantage of maintaining the soil cover, soil structure and biota and they have deeper root systems than annuals and thus provide soil stability and enhanced soil health. They can also tap available soil nutrients, enhance biodiversity, make more water available to plants, and capture and sequester carbon, increasing our carbon offset.

Our carbon footprint is currently estimated at between 40 to 80 tonnes per year on a national (not local) level. As our, in combination with our current waste reduction and energy-saving initiatives, new pastures and additional planting come into maturity we will see further reductions and ensure the continuous offsetting of our emissions far into the future.

## Committed to Green Energy Alternatives

Australia is a world-leader in solar energy and an environment for further sustainable energy sources, West Coast Fireworks is committed to tapping into these sustainable energy sources, where possible.

We have just recently built a purpose built building that is entirely off grid and uses sustainable solar and water technologies, this building is the location of our new Head Office and workshop and is now in full swing just in time for NYE 2022

### Scope of the project, including location and any significant challenges

The Albany family New Years Eve is a double display at 9pm and Midnight. Consisting of Children's entertainment, fun park, food vendors and all age competitions, It is a filled packed day starting at 7am with community breakfast. The fireworks are fired from one barge and a jetty in the bay area opposite ANZAC park, challenges being that we need to co-ordinate barge and jetty firing to seamlessly blend with soundtrack.

The fireworks synchronised to music must be able to be viewed from a couple of vantage points along ANZAC park, we also need to consider the suitability and placement of fireworks at this location so as to not close roads. The risks to this fireworks project was falling debris onto main roads and causing disruptions to traffic, 2021 this was planned meticulously in conjunction with local emergency services, we created a safety plan that was implemented by all parties, added additional fire safety equipment and personnel and had a hugely successful event. No damage to any person's, property or bushlands, because of this additional planning 2022 went off so seamlessly. We have been locked in until 2026.


The Rotary Club of Esperance in conjunction with the City of Esperance holds a NYE Family festival event.

In the event of Cancellation **from client**:

- Cancellation up to 21 days prior to the event will incur a fee of \$950 + GST. This will be invoiced, plus any additional fees outlaid for permits, Marine and Harbours where applicable.
- Cancellation between 21 and 5 days prior to event will incur a cost of 40%, of total value + GST.
- Cancellation for any reason other than inclement weather, from 5 days up to and including the night of event will be invoiced for 100% of the GST inclusive contract price.

### Inclement Weather

Due to regulatory changes over the past 2 years, a display cannot be held over or postponed for 24hrs. Current legislation dictates that the event must be fired within the timeframe listed on the permit and there is no flexibility in this.

If the display is cancelled due to inclement weather, such as natural disasters cyclones, earthquakes and bushfires, 25% of the total budget + GST will be invoiced. This is to cover out of pocket expenses, such as accommodation costs, fuel, permits, admin charges and labour.

In the event of rain, please be aware that shows can proceed safely in most instances. Provided that the winds are below 50 km/h, and following consultation with WCF Chief Pyrotechnician, client and any local safety services (St Johns, Dfes etc), a decision whether to proceed or not will be made on a case-by-case basis, with safety of our staff and the public being at the forefront.
